#### The Rotorua Citizens Advice Bureau provides free, confidential, impartial advice, information and advocacy on any issues or problems that anyone can access.

Common areas of enquiry for people over 55 are:

- Who can help to write a will.
- What should be included in a will.
- How to obtain probate.
- Requests for information on Enduring Power of Attorney – how to complete the forms, who can witness the signing of the forms, what happens if family members disagree with the decisions made by the Attorney.
- Information on eligibility for a Residential Care Subsidy.
- Gifting and family trusts.

These are just a few of the topics that the Volunteers at the Bureau can provide information on, but sometimes it is necessary to refer you to a lawyer - so we can provide names of local lawyers, including which lawyers do legal aid.

The Bureau also offers Justice of the Peace clinics three times a week, can assist clients who are struggling with digital communication with government departments, banks, utility services and can scan documents, create REAL Me accounts, as well as provide information on neighbourhood issues, employment, consumer, relationships and tenancy.





#### The Postie Stone Moffat, Scotland

A memorial to two dedicated postal workers who lost their lives delivering mail.

THIS ROADSIDE MEMORIAL COMMEMORATES THE lives of John Goodfellow. the coach driver, and James McGeorge, the coach guard of a mail coach. The pair were on a mail coach travelling from Dumfries to Edinburgh in February 1831. They became caught in a fierce blizzard which forced them to abandon the coach and set off on foot through the snow to try and deliver the mail and make it to safety. They took the mailbags and horses but eventually, the men were overcome by the elements and died of exposure near the head of Cross Burn. The horses continued on, eventually reaching a nearby farm which raised the alarm.

The stone was erected in their memory in 1931, a century after the event. The men were laid to rest in the churchyard in nearby Moffat.

### **Building Back Better**

In the wake of Cyclone Gabrielle, New Zealand is again talking about "building back better". But how do we build back better when we don't necessarily understand what "better" means? Or how to achieve this across a country with significantly different risk profiles?

At its most basic level, build back better is an opportunity to rebuild homes and other buildings in a way that is responsive to future risks and sustainability needs. To achieve this, we need to use the circular economy approach. A circular economy is one that swaps the typical cycle of make, use, dispose in favour of re-using and recycling as much as possible. A sustainable building in the circular economy model will minimise emissions and its impact on climate and natural resources across its entire life cycle. This life cycle includes the manufacturing of materials and construction, passive lifetime emissions, maintenance, as well as end-of-life requirements (deconstruction).

The New Zealand government has committed to the circular economy model in its plans to deal with waste.

Presently, we're building sustainable homes on the premise of being carbon neutral by 2050, but they also need to be built on the premise of being carbon neutral at the end-of-life in 50 years. We are not even close to achieving that. The solution to this issue may lie in modular homes and the development of new materials.

Quick and easy to make, modular homes provide fast options to house displaced people. They are also valuable for community wellbeing after the trauma of natural disasters. Finally, modular homes offer exciting opportunities for sustainability. They can be easily reconfigured to adapt to changing needs, for example, with the addition or removal of modules.

That said, modular homes are also not the cure all for the entire building industry. The global need for sustainable and resilient buildings is a driver for the development of new construction materials, such as the plasterboard substitutes saveBOARD and Neocrete, a low-emission concrete. These products offer low-emission building options, which use recycled materials in manufacturing and provide an alternative to high-emission materials. But, due to a lack of strict regulations around adopting new materials and a lack of awareness in the industry, adoption has been slow.

The adaptation of the circular economy approach to the "build back better" strategy for buildings will be essential in reducing the risk of future catastrophes, as well as the impacts on climate and natural resources.

The margin last reached this level in December 2014. The last time it was higher was in June 2006 when it hit 2.50%.

The interest margin is basically the difference between what they lend their (our) money out at, and what they pay to depositors.

Reserve Bank Governor Adrian Orr is on our side as he has just said he wants to see banks increase term deposit rates.

When interest rates reached rock bottom in 2020 and 2021, people took their money out of term deposits and put it into more liquid current or savings accounts.

As interest rates started rising, it took savers a while to put their money back into term deposits which pay more interest than regular savings account so cost banks more. David Tripe, Massey University Banking Professor believes there is room for banks to pay savers more for cash they keep in savings accounts. Hear hear.

A check on line on what other banks are paying can also help your request for a little bit more.

Bank profitability, measured by net interest margins, hit an 8 year high in the December

According to data collected by the Reserve Bank, banks net interest margins rose by 6 basis points to 2.37% in the final three months of 2022.

An important point is always ask for a little bit better than the bank standard 'blackboard' rate when you are renewing your deposit - you can often get a .1% increase on your deposit rate every little counts at our age.



## **AIR Studio Ruins** Montserrat

#### George Martin's Caribbean recording studio now rots within the shadow of an active volcano.

THE RUINS OF BEATLES PRODUCER George Martin's Montserrat recording studio now crumble within the shadow of a volatile active volcano that's been wreaking havoc on the island since the 1990s.

Dried mud and ash cake the buildings, and murky rainwater fills the outdoor swimming pool. Wasp nests plug various nooks and hang from the ceiling as tangles of vegetation climb the walls. Forgotten bits of the recording equipment that used to produce so many albums rot inside.

You can't tell by looking at it now, but the grimy complex was once a hot spot for the musical greats

of the 1980s. George Martin, the famous English record producer and musician who was sometimes called the "fifth Beatle," opened AIR Montserrat on the Caribbean island in 1979. It was a branch of Associated Independent Recording (AIR), the recording company he co-founded.

Martin's island oasis studio was soon one of the most prolific recording studios of its era, cranking out a total of 76 albums. Musical legends like

the Rolling Stones, Elton John, Stevie Wonder, Jimmy Buffett. Paul McCartney, and Michael Jackson recorded within its state-of-the-art walls. Musicians spent days or weeks creating their records at what was then a small sliver of Caribbean paradise.

But only a decade after the celebrated studio opened, its life soon came to an abrupt end. When Hurricane Hugo swept across Montserrat in 1989, the storm devastated much of the island and forced the studio to shutter. Then, only six years later, the Soufrière Hills volcano erupted, bombarding the land with lava flows and thick layers of ash. (Jimmy Buffett's album Volcano, which he recorded in the studio, was named for the then-dormant volcano.) The ongoing volcanic eruptions have made nearly half of the island uninhabitable. The decaying ruins of the studio stand near the fringe of the exclusion zone. Now too fragile to safely walk within, the studio bears little, if any at all, resemblance to its original grandeur.

### **Delivering more Nurses** and Midwives.

Worryingly an increasing number of local people have been talking to me about the health system and how much it has changed over the last five years. In fact, they have become increasingly concerned as they or friends and family wait for an operation or medical treatment. For some they just can't get to see a GP or specialist.

At a time when our doctors and nurses and healthcare workers are under extreme pressure the Labour Government has made some terrible decisions that's made it harder to get treatment not better.

More Wellington bureaucrats and an expensive health restructure has resulted in a considerable increase in wait times for surgery and overcrowding in emergency departments. Furthermore, there is a growing list of Kiwis who are facing increasing delays for those who need access to urgent cancer treatment.

Our nurses are at the frontline of this and are bearing the brunt of the nursing shortage New Zealand is experiencing. We now have a shortage of at least 4000 nurses across the country.

Over the last five years we have lost 19,000 nurses from the public system, which is far more than we have trained. Nearly 5,000 have registered to work in Australia since August last year, and a third of our nurses say they are considering moving overseas.

National has a plan to change this. We will deliver more nurses and midwives to address the shortage so you can get the treatment you need. Chris Luxon recently announced policy that will:

• Provide Incentives to encourage more Kiwis to study nursing or midwifery

To provide the level of health care we need, there has to be a significant increase in the number of people studying for a career in nursing or midwifery. National will pay nurses' and midwives' student loan repayments up to a total of \$4,500 per year for the first five years of their career. This means a nurse or midwife over five years would be \$22.500 better off.

• Bonding to retain nurses in New Zealand once they graduate

To access the student loan repayment scheme,

nurses and midwives will need to enter into a bonding agreement with Government where they commit to working in New Zealand in their profession for at least five years after they graduate.

This scheme will also be open to registered nurses and midwives who are already in the workforce on a pro-rata basis. For example, a nurse who has already been in the workforce for two years would be able to sign up for the remaining three years of student loan repayments in return for three years of bonding. This will provide more support to the health sector to retain early-career nurses and midwives in New Zealand.

#### **Competitive immigration setting to attract** more overseas nurses and midwives

Given the significant and urgent shortages facing our health sector today, we need to supplement training and retaining more nurses at home by recruiting more from overseas.

National will make it easier for competent, gualified overseas nurses and midwives to choose New Zealand as their next home by removing barriers to migration and making our offering more competitive with other

We will do what it takes to ensure we get the skilled migrants we desperately need into our hospitals and other health care facilities so we can bring down waitlists and ensure Kiwis get access to the health care and maternity services they deserve.

### **Delivering for Waiariki through trade**

Our Government's historic record on trade is providing greater opportunities for New Zealanders to get ahead. We've unlocked access to some of the world's biggest and most lucrative markets. So I'm pleased to share that we're bringing forward our trade agreement with the United Kingdom, and I wanted to let you know what that means for Waiariki.

While overseas last week, Prime Minister Chris Hipkins announced that New Zealand's new trade agreement with the United Kingdom will enter into force early, delivering unprecedented access into the UK market by the end of this month.

This is great news, particularly for local exporters, farmers and growers, as the deal is gold-standard. It's expected to boost our economy by up to \$1 billion a year, with New Zealand exports to the UK estimated to grow by over 50%.

From day one the deal will cut costs for Kiwi exporters, saving them approximately \$37 million a year in tariff elimination alone. In fact, 99.5% of current exports will enter the UK duty-free through a combination of tariff elimination and duty-free quotas.

It will also unlock opportunities for Waiariki businesses to boost and diversify their trade – helping them to succeed and to grow jobs and wages. On top of this, it will help to bring down the cost of living by delivering price-competitive UK imports.

Sixty representatives of retirement village Residents Committees across the country have signed the letter while hundreds of residents have also backed the letter in emails to the Retirement Villages Association (RVA). Collectively, the committee chairs and residents represent more than 10,000 village residents.

"The retirement villages sector and our residents have been concerned for some time about the inaccurate and sometimes demeaning comments about retirement village living," says John Collyns, executive director of the RVA, which facilitated and placed the letter.

"That's fuelled a massive response from retirement village residents who jumped at the opportunity to support this open letter.

"The residents I talk to are angry and frustrated at the suggestion they have been somehow hoodwinked into moving into a village.

"Our residents may be older but they are certainly not stupid. Independent research shows overwhelming satisfaction rates among residents and 100 Kiwis are moving to a village every week.

"Many residents are puzzled at the picture some commentators paint about retirement village living, which is at odds with the experiences of most village residents.

"The residents I talk to are really happy with their decision to move into a village. They did their homework, they talked with family and friends, engaged a solicitor to review the contract as is required under the law and visited a range of villages - they made an informed decision so let's give our residents some credit.

"Our research shows most people move into a village for the lifestyle. They don't want to worry about ongoing maintenance or insurance, they want a greater sense of security, companionship, a community and the convenience of on-site healthcare services.

"However, we have always accepted the need for improvements to the sector's consumer protections regime where they are feasible and make sense.

"We have already announced significant changes to the way we operate including addressing unfair clauses in Occupation Rights Agreements and best practice disclosure guidelines regarding residents' transfer to care."

"The majority of operators have already stopped charging fees after termination and many other villages are following."

"The RVA's Blueprint for Improvement has a target of all villages to institute some best practices and later this year these currently voluntary provisions will be voted on by RVA members to become mandatory."

"We are also working constructively with the Ministry of Housing and Urban Development through a review of the Retirement Villages Act."

#### **Transparent Restroom**

Tokyo, Japan

#### These unique toilets feature transparent glass covered in PDI C film.

IN 2020, UNUSUAL PUBLIC TOILETS were installed in two parks in the ever-popular Yoyogi district of Tokyo and guickly, although for a brief period, became an internet sensation. The stalls, in particular, are guite easy to find, encased by transparent glass walls of a variety of vibrant colours, looking immaculate and yes, you read it right: the restroom's walls are transparent, totally seethrough.

You can see everything inside, from the flush toilet to the hand wash sink. Now the question is, how does one use it? It's guite simple, actually. Once you go inside and lock the door, the walls automatically turn opaque, obscuring the user. The walls are made of glass covered with PDLC film, which renders them transparent when electricity is applied. Locking the door turns off the electricity, giving the glass walls its original opacity back.

The innovative design was conceived by Shigeru Ban as a response to the park-goers' need for a safe and comfortable restroom, where one can be sure that the toilet is clean and that nobody is hiding in the stall. It's part of the ongoing THE TOKYO TOILET project led by the Nippon Foundation, which seeks to improve public restrooms across Shibuya City, making all of them accessible and comfortable while giving them a bit of artistic twist.
